Dear President Trump:

We are concerned by your decision to initiate a withdrawal of the United States from World Health Organization (WHO). It is critical that the U.S. remains a global leader in public health to protect the interests of Americans. We urge you to remain in the WHO and to provide continued guidance on reforms that make the organization even more accountable and cost-effective, that strengthen America's leadership role, and that advance our national interests. U.S. leadership in WHO will make our country safer, stronger, and more prosperous – but only if America continues to lead.

For a fraction of the budget of some U.S. state departments of health, WHO works with over 150 nations to detect, prevent, and combat deadly diseases abroad before they threaten the American people. Every month, the agency provides critical intelligence, analyzing over 100,000 health threat alerts circling the globe – any one of which could become an outbreak or the next pandemic. Continued U.S. leadership within WHO ensures that we maintain access to this vital early knowledge of diseases that could reach American soil in a matter of hours.

America's smart investments in global health benefit hardworking people and communities here at home. In 2023 alone, WHO and the UN bought \$812 million in medicines and other health products from the United States – more than any other country and nearly twice as much as America contributed to WHO that year. These investments support American jobs, foster innovation, and contribute to our national economic strength.

With America at the forefront, WHO has conquered some of humanity's biggest killers, eradicating smallpox, eliminating polio in 145 countries, and declaring 44 countries and territories malaria-free. The organization also works with the private sector and premier U.S. research institutions to approve safe and effective medical products for the global market, while also monitoring and alerting the world to the spread of substandard or counterfeit medicines. The next four years are a chance to build on these capabilities and achievements and address new and evolving health threats that endanger Americans, including bird flu and deadly fentanyl.

U.S. leadership is critical to preventing geopolitical adversaries, including China and Russia, from influencing global public health to their own benefit. Our country's influence includes hundreds of American staff who play a pivotal role representing U.S. policy priorities and directing the organization's global work – outnumbering employees from China by a margin of three to one. Being at the table provides a unique opportunity to shape and influence the election of the next Director General, which is likely to take place within the next four years. Our country's leadership has already helped WHO implement major reforms that have transformed the agency's accountability, cost-effectiveness, and country impact, and we must continue to guide the agency's evolution.

Simply put, America's national health, economic, and security interests are best served by leading WHO from within. The recent announcement should mark the beginning of this discussion, not the end. We stand ready to support your Administration's efforts to engage with WHO to advance America's health security and ensure our nation's priorities remain at the forefront of the institution.
