II. Discussion

A. Old Business

Betty Daniels

Executive Board Liaison grid: At the request of the Executive Board chair, Ms. Beal, Ms. Navale, and Ms. Roques worked together to clarify the process of the Executive Board liaison initiative. Ms. Beal then walked the Board through the process and said both the Executive Board liaison grid document and Executive Board handbook have been updated. The following is an abbreviated version of the process:

- 1. Following an Executive Board meeting, APHA staff will share the meeting notes with the Board.
- 2. The Chairs of the ISC, CoA, and Student Assembly will share the meeting notes with the members of their Council/Assembly.
- 3. APHA Executive Board members will follow up with their liaisons to see if they have any questions related to the meeting notes.

Pathways to Leadership Workgroup: The Pathways to Leadership Group hasn't met since before the Annual Meeting. APHA staff are working with the members of the group to identify a meeting time. The group will meet before the May meeting of the Executive Board.

B. Report of the Treasurer

Seven months into the fiscal year, APHA's net assets are looking well due to the decrease of operational expenses and increase in revenue. The total net assets as of January 31, 2019 were \$21, 353,749, over budget by \$1,320,072 from prior year 2018.

The year-to-date income from operation is \$12,575,573 (over budget by \$357,618) and expenses totaled \$10,020,626 (under budget by \$59,991). This results in income from operation of \$2,554,946 (over budget by \$417,609). Investment income and appreciation added additional revenue of \$283,391 (over budget by \$84,338) which results in overall income of \$2,741,385 (over budget by \$501,947).

Mr. Hernandez also gave a detailed budget summary of the four main categories of revenue; Membership is under budget, Conventions is over budget by \$247,319, Publications is under budget by \$224,308, and Grants and Contracts is over budget by \$414,839 as APHA received more than what was anticipated for CDC grants.

On another note, the Finance Committee voted to keep the current auditors for an additional three years.

C. Association Update

Georges Benjamin

Membership

Executive Director Georges Benjamin gave a thorough rundown on the status of membership for each category under individual, student bulk, agency individual, affiliate, and agency. As of January we have 21,847 members. APHA has already reached out to many lapsed members to renew their membership.

For new agency members, APHA will follow an expedited approval process granting temporary approval by the executive director. This will help APHA to collect membership dues and for the agency to begin registering any individual membership (AGI's). The board will officially approve the agency during the scheduled board meetings. Any new agency members the executive director feels may need a full discussion of the board will not be approved by the expedited process.

Endowment Proposal

Dr. Benjamin presented the proposed Ayman El-Mohandas Young Professional Public Health Innovation Award to the Executive Board for their discussion and approval. The award will be given annually to an early career professional member of the Association (40 years old or younger) for creating an innovative solution to the world's most complex public health problems. Dr. El-Mohandes would fund the award over a period of 10 years, and the award would be self-sustaining.

Internal Restructure

The Executive Director is actively working on the internal restructuring process and will present the progress with dates during each board meeting.

APHA Policy Action Institute

Very successful event co-hosted by APHA and the AcademyHealth, and attended by 306

people.

One of the keynote speakers was the House Speaker Nancy Pelosi. Speaker Pelosi highlighted her effort in engaging public health discussion in Congress and priorities of the House. Other keynote speakers included Assistant Secretary of Health Admiral Brett Giror who discussed the government's initiative on eliminating HIV/AIDS, and former acting U.S. Surgeon General Dr. Boris Lushniak, who talked about the Policy Action Institute theme of *Public Health Under Siege: Improving Policy in Turbulent Times*.

Other prominent speakers included former Gov. Dannel Malloy of Connecticut, former U.S. Congressman Henry Waxman, President of Planned Parenthood Dr. Leana Wen, and President and CEO of AcademyHealth Lisa Simpson, among many others.

Healthiest Cities & Counties Challenge

Funded by the Aetna Foundation in partnership with APHA and National Association of Counties, this two-year challenge award of \$1.5 million empowers small to mid-size U.S. cities and counties to create a positive impact through innovative initiatives that address social determinants of health.
