



PUBLIC HEALTH PROGRAM STUDENT ENROLLMENT PROGRAM

FREQUENTLY ASKED QUESTIONS

Who is eligible to enroll in public health discount student enrollment program?

Any educational institution that offers a public health curriculum is able to participate in the APHA discounted student membership program.

What is the fee to participate as a school of public health?

There are two membership options a university can choose from. One is calculated using a sliding scale based on the mean of the number of students enrolled (average) times a fee of \$57. The other is based on a flat cost of \$57 per student. Note: These are annual fees.

Sliding scale option:

Number of students	Mean	Cost
1 - 100	50	\$2,850
100 - 200	150	\$8,250
200 - 300	250	\$14,250
300 - 500	400	\$22,800
500 - 800	650	\$37,050
800 - 1,200	1,000	\$57,000
1,200 - 1,700	1,450	\$82,650

Must all students be enrolled to receive the special discounted rate?

Yes, all students participating in the program must be enrolled in order to qualify for the group discount.

Where does the \$57 rate come from?

The \$57 rate represents a 33% discount off of the regular APHA student rate of \$85.

Who is responsible for payment of the membership fees?

The college or university is responsible for payment for all its students.

What forms of payment are accepted?

Payment may be made from the college or university by check (payable to APHA) or the following credit card options: American Express, Discover, MasterCard and Visa.

Does my educational institution have to provide proof of status to be eligible?

Proof of the number of public health students is required.

Once approved, how do I enroll my students in the program?

The school will be responsible for providing a list of all students with applicable contact information to APHA to enroll their students. A template will be provided for the school administrator to complete. The school will then be provided with a designated group code students will be directed to use to select their two sections and finalize their membership.

What benefits does the university and its students receive?

Benefits include:

- One complimentary faculty membership per 100 students enrolled
- Online access to ***The Nation's Health*** and the ***American Journal of Public Health***
- Personalized online community
- Students are automatically enrolled in APHA's Student Assembly
- Students may participate in two APHA Sections of their choosing
- Students may participate in APHA's Special Primary Interest Groups, Forums and Caucuses of their choosing
- APHA Annual Meeting student discount
- If their abstract is accepted, students are able to present at the APHA Annual Meeting
- Publication discounts on APHA publications
- Public Health CareerMart access and discounts on career services
- Access to National Public Health Week toolkit
- Access to PHACT Campaign toolkit
